Calcium Gluconate Injection, USP 10% 100 mg/mL Vial Backorder Notification

Dear Valued Customer,

Fresenius Kabi Canada regrets to advise that due to production delays, we will be experiencing a supply interruption on **Calcium Gluconate** Injection, effective, November 1, 2021 to December 31, 2021.

Calcium Gluconate Injection, USP 10% 100 mg/mL Vial **100 mL** will be on 100% allocation for the month of November and 50% allocation for the month of December based on historical demand.

Calcium Gluconate Injection, USP 10% 100 mg/mL Vial **50 mL** will be reduced to 50% allocation for the month of November. Allocations of Calcium Gluconate Injection, USP 10% 100 mg/mL Vial **10 mL** will be increased to cover 100% historical demand of the 10 mL <u>plus</u> the remaining **50% demand of the 50 mL on a mL per mL basis (5:1 conversion ratio).** For example: 5 vials of 10 mL = 1 vial of 50 mL.

Calcium Gluconate Injection, USP 10% 100 mg/mL Vial **50 mL** will be on backorder for the month of December. There will not be sufficient inventory of the 10 mL remaining to provide coverage of the 50 mL in December. Calcium Gluconate Injection, USP 10% 100 mg/mL Vial **10 mL** will revert back to 100% allocation of **10 mL** historical demand for December.

We are working diligently with our plants to expedite production and will advise of any updates should there be any improvements to the timelines and allocations indicated above.

We recognize the difficulties and inconvenience that you may encounter as a result of our supply interruption, and we thank you for your patience and understanding in this matter.
