- Serve as contact point within the framework of gSOP Case Management (whistleblowing and investigations)
- Report on Compliance Management System Reporting (CMSR) and the results of regular Compliance Risk Assessments
- Develop adequate local Compliance communication material
- Offer training and guidance to employees in Compliance related matters, including particular local legal requirements and the onboarding of new employees
- Monitor the legal environment for relevant changes in legislation and identify necessary adjustments within the local/ELT area Compliance strategy
- Manage (respectively support) internal Compliance investigations as well as the implementation of disciplinary sanctions
- Assess Compliance-relevant issues with regards to third party checks, due diligences and approvals

### **Legal Affairs:**

- Responsible for legal department in BENE, act as SPOC for all local legal affairs.
- Handling legal issues, which may include topics such as patents, antitrust, GDPR, penalties, HR matters, claims, tenders
- Responsible for contract management, such as sales contracts, marketing partnerships, NDA's and verndor agreements
- Collaboration with external legal counsels
- Translate corporate laws and regulations into local actions
- Support internal and external audits, certifications processes, and internal investigations.
