IV Solutions Allocation Notice

Dear Valued Customer,

A major supplier of IV solutions in the US has had their manufacturing plant severely impacted by hurricane Helene and impact on Global supply is still unknown. **Fresenius Kabi's manufacturing is not impacted.**

As a preemptive measure to protect supply for Fresenius Kabi Canada's customers, all IV solution products will be placed on allocation **effective October 8th, 2024**. Contract customers will be allocated **100%-125% of historical monthly demand** for the below products. This is a preemptive, protective measure only and Fresenius Kabi Canada is working to remove the allocation status as soon as it is safe to do so.
