## **2. We collect and use your personal data...**

### **...to answer your inquiries you sent to us by direct message.**

We process your personal data in order to be able to answer your inquiries sent to us by means of a direct message via the respective social media network or platform.

To do this, we always process your name as selected by you for your social media user account. In addition, we process all personal data that you send us with your direct message.

In order to answer your inquiry correctly, we will redirect it to the relevant department within the Fresenius Group, which can best answer the respective inquiry. An answer to the inquiry will either be sent by the relevant department of Fresenius or we will send the answer formulated by the department directly via direct message via the respective social media network or platform.

We store your data for as long as it is necessary to answer your inquiry. So until you receive the last relevant message from us to answer your query, plus a 6-month transition period so that we can respond if you have any further or follow-up questions.

We process your personal data on the basis of our legitimate interests in being able to answer your inquiries, as well as the fact that your interests, rights and freedoms do not override this interest, Art. 6 para. 1 lit. f GDPR.

**...to follow up and report on posted adverse events.**

As a pharmaceutical manufacturer, Fresenius Kabi AG is legally obliged to collect, document and report your posts on our social media presence to the responsible health authorities if they describe events relevant to drug and medical products safety.

This message may also contain personal data about you if you have published it in your posts.

We store this data for the duration of the legal retention period in accordance with the legal obligations existing in the respective countries, which also determine the duration of the respective retention. In the European Union, these include inter alia Section 63c of the German Medicines Act and Article 24 of Regulation (EC) No. 726/2004.

We process your data to fulfil this legal obligation to which Fresenius Kabi AG is subject, Art. 6 para. 1 lit. c GDPR, and the fact that you have published this information yourself in the form of a posting on the respective social media network or platform, Art. 9 para. 2 lit. e GDPR.

**...to gain insights in our and your online presence.**

Together with some social media providers, such as Facebook, with which we maintain an online presence (such as a Facebook Fanpage), we have the possibility, with the help of profiles made available by the respective social media provider, to produce statistics on your visits, interaction and content of the respective online presence.

These statistics are anonymous to Fresenius Kabi and do not enable Fresenius Kabi to identify individual visitors. The criteria offered for selection to us entails inter alia trends in terms of age, gender, relationship and occupation, centers of interest, and geographical data.

We use these statistics in order to adapt our online presence with the respective platform or network to best suit the preferences and interests of its users.

We process your data based on our legitimate interest in providing an adequate online presence which meets the demands of the users, and the fact that this interest is not outweighed by your interests, rights and freedoms, Art. 6 sec. 1 lit. f GDPR.

#### **...where we engage service providers**

Processors who process data as service providers for Fresenius Kabi in accordance with Fresenius Kabi's instructions, including international platform and hosting providers and providers of management tools for social networks, including Facebook, to accomplish our purposes based upon our instructions. Except where such providers are also controller as mentioned under "Responsibility of social media providers", they are not allowed to process your personal data for their own purposes.

#### **4. You have the right to...**

##### **...obtain confirmation**

You have the right to obtain from Fresenius Kabi confirmation as to whether or not personal data concerning you is being processed, and where that is the case, access to the personal data. You can submit an application by post or e-mail to the above address.

##### **...get your data rectified**

You have the right to request from Fresenius Kabi the rectification of inaccurate personal data concerning you. Please contact the above addresses.

##### **...ask for erasure**

You have the right to request from Fresenius Kabi the erasure of personal data concerning you under the prerequisites put up in Art. 17 GDPR. These prerequisites inter alia provide a right to erasure, if data is not necessary for the purpose it was collected for, in case of an unlawful processing of personal data, if the personal data have to be erased for compliance with a legal obligation in Union or Member State law to which Fresenius Kabi is subject, or if you have withdrawn your consent and there is no other legal ground for the processing. To exercise the aforementioned right, please contact the above addresses.

##### **...have your data restricted of processing**

You have the right to request from Fresenius Kabi the restriction of processing if the prerequisites of Art. 18 GDPR apply. This right exists inter alia, if the accuracy is contested by you, for a period enabling Fresenius Kabi to verify the accuracy of personal data, if the processing is unlawful and you contest erasure and demand restriction of their use instead. To exercise the aforementioned right, please contact the above addresses.

##### **...data portability**

You have the right to receive your personal data, which you have provided to Fresenius Kabi, in a structured, commonly used and machine-readable format and have the right to transmit those data to another controller without hindrance from Fresenius Kabi under the prerequisites of Art. 20 GDPR.

#### **...object to the processing**

**You have the right to object, on grounds relating to your particular situation, at any time to processing of personal data concerning you which is based on Art. 6 sec. 1 lit. e or f GDPR, according to Art. 21 GDPR. We will no longer process your personal data unless we can demonstrate compelling legitimate grounds for the processing which override your interests, rights and freedoms or are necessary for the establishments, exercise or defence of legal claims.**

#### **...lodge a complaint**

You also have the right to lodge a complaint with a European supervisory authority.
