

Information obligation according to the General Data Protection Regulation (Art 12 et seq. GDPR)  
Who is responsible for processing the data and for which purposes do we process the data?

Fresenius Kabi Austria GmbH, Hafnerstraße 36, 8055 Graz, [datenschutz.austria@fresenius-kabi.com](mailto:datenschutz.austria@fresenius-kabi.com), processes personal data as a data controller in the sense of the data protection regulations exclusively for the fulfillment of our contractual obligations:

We are required by law to submit data on side effects of our products to the competent authorities.

Therefore, if you report a side effect, we will process that information to fulfill our legal obligations.

To whom do we transfer your data?

For the execution of the contract, the data are generally not forwarded to any third party, but remain internally in-house, only in necessary cases, there is a transfer to exclusively certified processors. Furthermore, we will submit your data to the relevant authorities, if this is necessary in the context of the adverse reactions report.

How long will your data be stored?

We only store your data as long as a statutory retention obligation stipulates or as long as a liability claim against Fresenius is possible.

As the person concerned you have the following rights:

- Right to information: Fresenius Kabi Austria GmbH gives you upon written request a free of charge information about the source, the origin and the recipients of the stored data as well as the purpose of the storage;
- Rectification: If you, as the person concerned, notice that the data is incorrect, Fresenius Kabi Austria GmbH will promptly correct this data upon request;
- Erasure: Under certain conditions, you are entitled to request an erasure, eg in the case of an objection or unlawful processing. Fresenius Kabi Austria GmbH as a data subject can only grant a right of erasure insofar as no statutory retention periods preclude this erasure.
- Restriction: As the person concerned, you may request a restriction of data processing in addition to an erasure claim. In this case, Fresenius Kabi Austria GmbH will no longer use your data for any other purpose, except, for example, for purposes of securing evidence.
- Objection / Revocation: As the person concerned, you can object to or revoke your consent to the processing of your data at any time. The revocation of the consent / the opposition does not make the data processed so far unlawful. Should you revoke your consent or object to the processing, then we can not continue to supply you.
- Data portability: Upon your request, Fresenius Kabi Austria GmbH will transfer data directly disclosed by you, provided they do not concern third-party data, to another controller, if the transfer is requested in a common electronic format.

- Right of complain to the Data Protection Authority: You have the right to lodge a complaint with the supervisory authority if you suspect that Fresenius Kabi Austria GmbH has not processed your data in good faith.
